**Dear EWIS participant,**

Welcome to Kraków! The European Workshops in International Studies (EWIS) were launched by EISA at the University of Tartu, Estonia, in 2013. The first keynote was given by Professor Barry Buzan (LSE) on the origins of the modern global order in the long nineteenth century. The 6<sup>th</sup> iteration of EWIS in Poland's cultural capital (and former capital city) marks the contested 100<sup>th</sup> anniversary of our discipline from its generally agreed beginnings in 1919, when the first department and chair in International Politics were founded in Aberystwyth, Wales. Following the 2018 EISA Pan-European Conference (PEC) on International Relations in Prague and trailed by the EISA PEC2019 in Sofia, Bulgaria, EWIS 2019 in Kraków also signifies the coming-of-age of Central and East European academia in the radically broadened playing field of the European IR. As far as IR's benchmark dates are concerned, we have turned full circle.

EWIS have quickly established themselves as a vivacious place for the European IR community (and beyond) to engage in sustained, in-depth discussion with a diverse range of peers from various institutions, countries, disciplines and career stages. EWIS has proven to be a popular and productive format, perfect for preparing special issues, edited volumes or exploring new ideas, themes and directions in a vibrant and friendly atmosphere.

The home of EWIS 2019, organised in collaboration with the Polish Association for International Studies and the City of Kraków, is the Jagiellonian University – the oldest higher education institution in Poland (founded in 1364), a key academic hub in Eastern Europe, and an increasingly important centre for IR in Europe more widely. The university is situated in the heart of the city, which allows easy access to the medieval old town's rich history as well as its youthful and dynamic nightlife. Easily reachable by air and land (Kraków international airport is the second busiest of Poland and well-served by major European airlines), Kraków combines a graceful charm of a great historic city and a relaxed vibe of an accessible university town.

The workshops that we selected will provide manifold explorations of the EWIS 2019 umbrella theme – The Next 100 Years of IR. They will gaze into the crystal ball of the future of International Relations in distinct ways, covering the main sub-fields of the discipline, taking stock of the past achievements and pushing the scholarly agenda in novel directions. With the 6<sup>th</sup> iteration of the event we are delighted to welcome twenty-five forward-looking workshops and their participants, while maintaining the intimate spirit of EWIS and its small-group workshop format. We hope to further consolidate EWIS' reputation as the most intellectually productive IR conference format in Europe – and one that supports inclusive participation through a commitment to accessible facilities. We are also delighted to have been able to provide substantial mobility grants to 15 participants, a practice started in EWIS 2018 in Groningen and hopefully to long live *in spe*.

We are also happy to honour the EWIS tradition of an exciting social programme, including a welcome reception, 'happy hours' on the first day of workshops (an affordable version of the expensive hotel bar at standard large IR conferences), and a day of fascinating cultural excursions in and around Kraków on Saturday that will give you plenty of chance to meet and discuss with participants from other workshops. We hope that EWIS 2019 in Kraków provides an intellectually productive as well as enjoyable and memorable experience.

All of this would not have been possible without the hard work behind the scenes by the workshop conveners, the Jagiellonian University organising team, the staff of EISA, as well as numerous student helpers. We trust that you will all join us thanking them for their work.

We hope you enjoy the event, and look forward to meeting you, catching up – and to getting your feedback – during one of the social events at EWIS 2019.

## Plenary Roundtables, 26 June 2019: The Next 100 Years of International Relations

EWIS 2019 kicks off with two plenary roundtables exploring the convention theme – ‘The Next 100 Years of International Relations’. The roundtables continue the democratic spirit introduced at EWIS 2018 in Groningen: we will deliberately depart from the conventional keynote format by bringing together scholars from a broad variety of perspectives in order to showcase the bottom-up dialogical character of EWIS as a whole. We are excited to welcome leading scholars and rising stars from around Europe but also from around the world – reflecting the growing reach of EWIS – to participate in these roundtable discussions. It is our hope that the two plenaries will provide a welcome spark for the ensuing workshops in the next two days.

The first roundtable will pave the way for unpacking the future-looking intent of the conference title: What should we cherish from the history of doing IR, and take forward to the next hundred years? What should better be forgotten and abandoned as poor practice, unsavvy and unethical conduct of studying world politics? Is the slogan of the business world - what got us here won't get us there – applicable to the study of IR? In which ways is the history of the discipline illuminating for carving out the better angels of our nature – and future? In what sense can the first official 100 years of IR serve as a warning? Or is it high time to rid us of the shackles of the centenary chronotope of Western IR and join the increasing calls to widen the discipline's theoretical and historical scope by also radically revising its orthodox benchmark dates? How does the history of the discipline weigh on the daily choices we make in our own scholarly work?

The second roundtable will provide additional perspectives on these themes and give the participants a chance to reflect on what the previous speakers contributed, with an eye firmly to the future – to *what is to be done and how to do it* in order to make the next century of IR a more global and historically aware, a less parochial, and altogether an ever more exciting one. What is in store for IR's next hundred years? Which forces of world politics currently shape our discipline as it begins its second century? What role do we envision for International Studies in the world where academic freedom in general and social sciences in particular are under pressure? To what degree is contemporary IR what we – the scholars of International Studies – make of it? The second plenary will ponder how IR scholars could with their own daily labor, work and action bring about positive, transformative change to the study of world politics. The speakers will discuss different ways of scholarly practice, method, responsibility and social engagement to probe the future of IR's analytical object, and the modalities of engagement of our disciplinary gaze and touch.

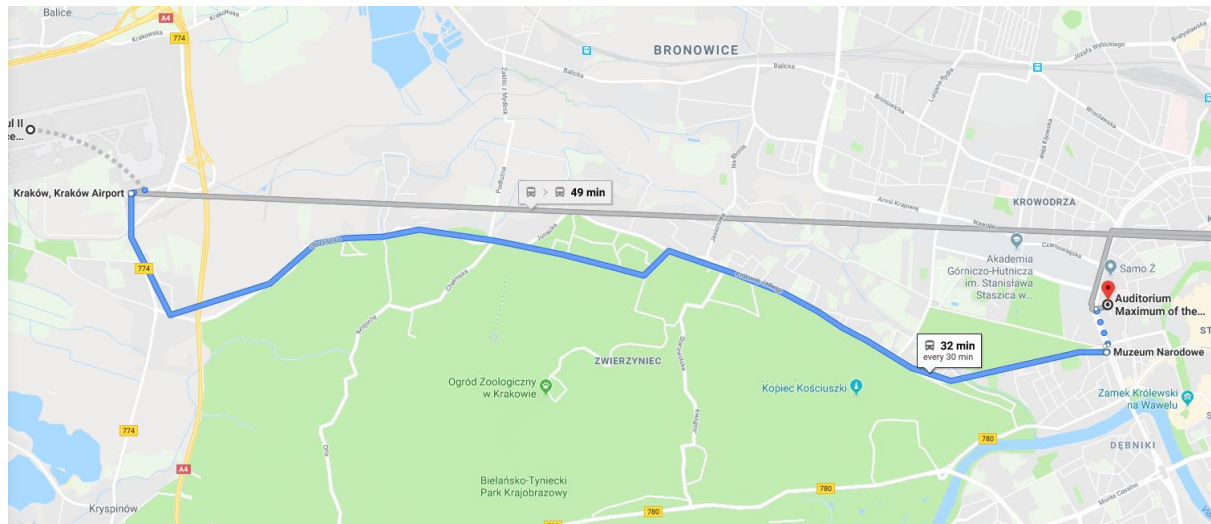

### Arriving from the airport

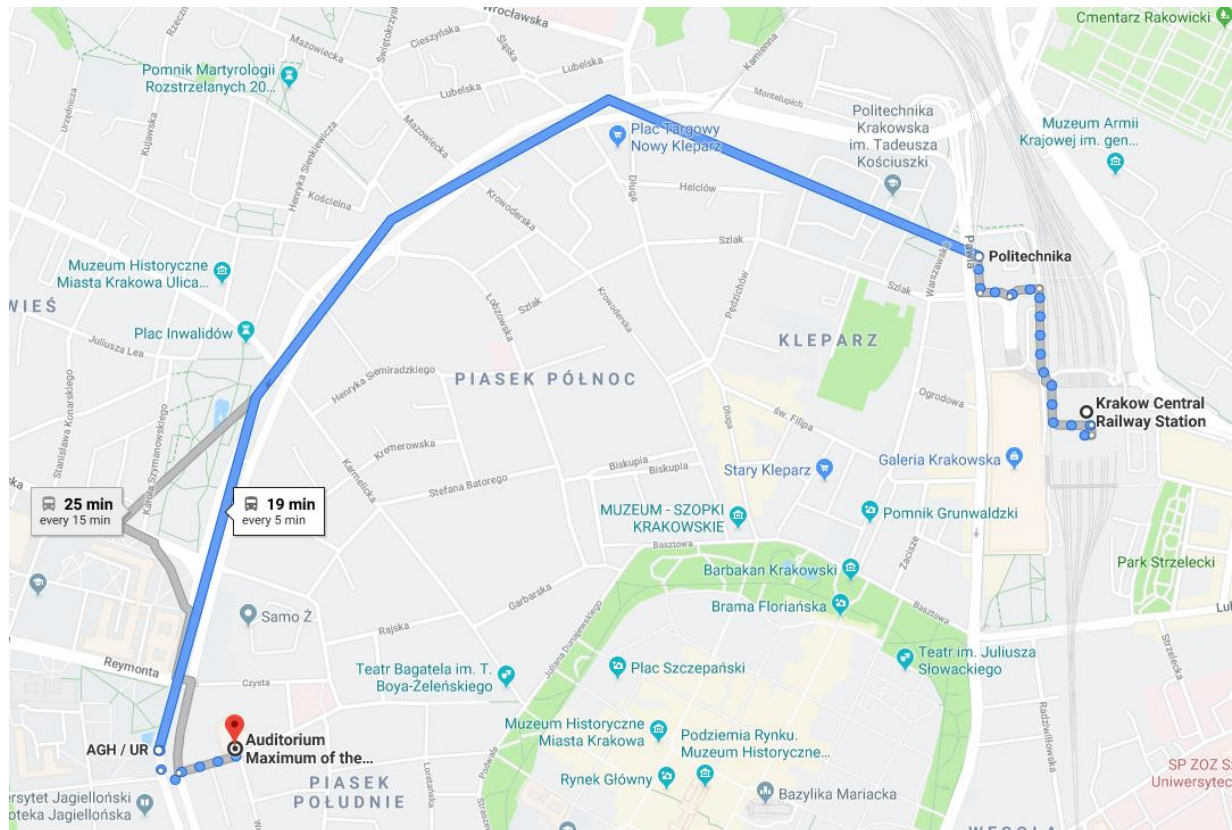

## Arriving from the main railway station

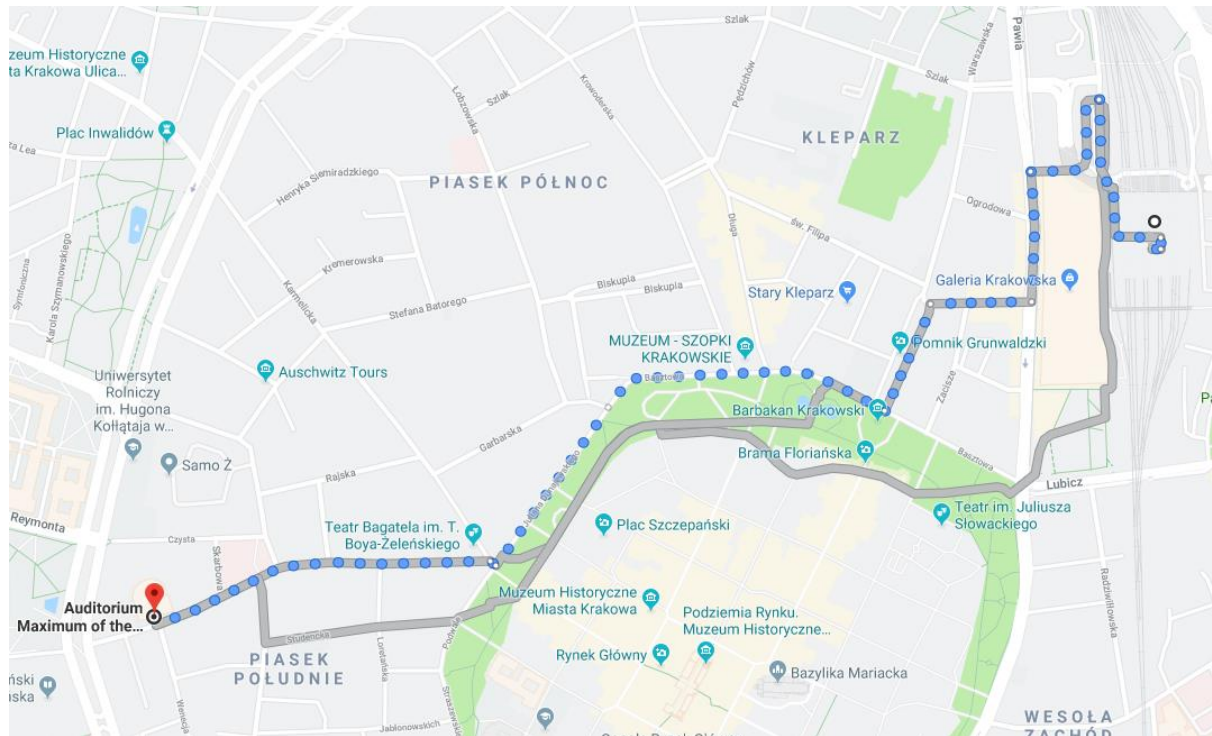

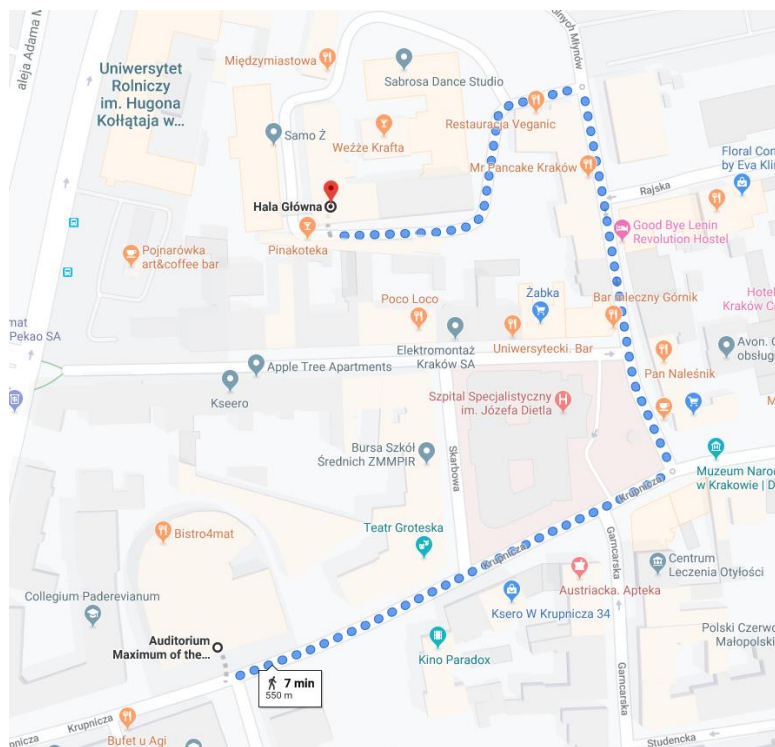

## Getting to the EWIS Happy Hours site

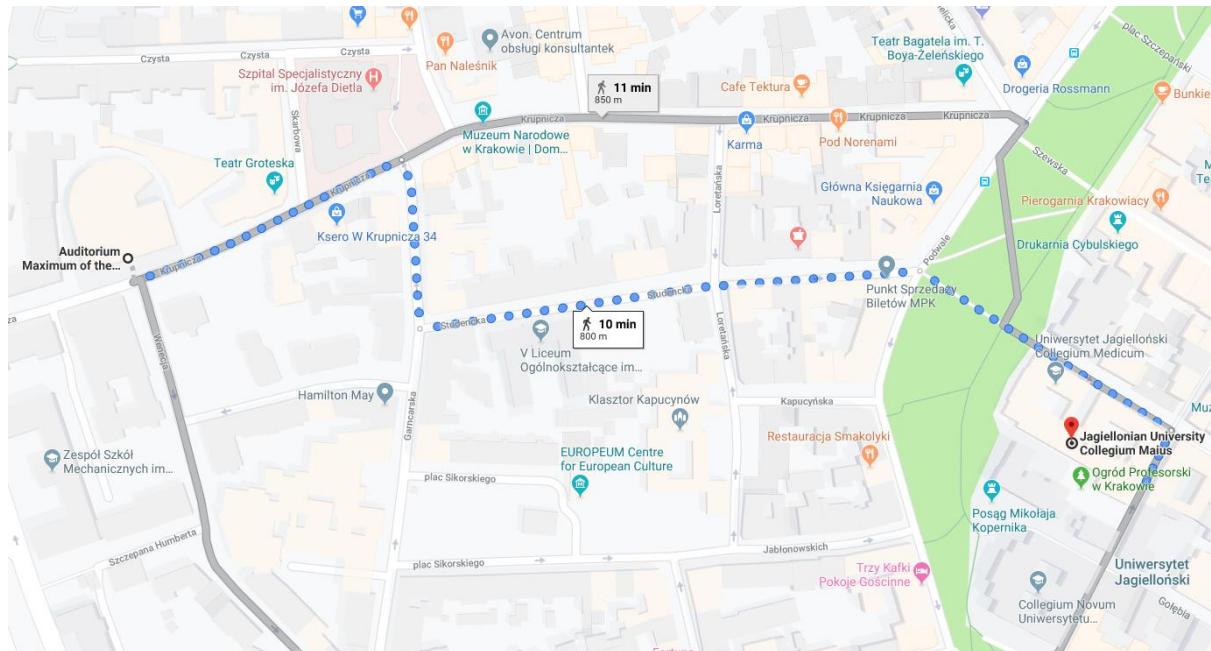
The location of EWIS Happy Hours - Hala Główna – is only two blocks away from the Auditorium Maximum, approximately 550 metres / 7 minutes by walking.
