

Workshop Title: Decolonizing Affective Attachments in Global Politics

Call for Participants:

This workshop proposal responds to has been called 'an affective turn' in IR and global studies, through addressing the relative inattention to the politics of emotional attachments, both human and non-human, centred in the Global South. The workshop aims to explore the intersections of the affective with embodied, gendered, racialized, and classed subjectivities, geographies and histories in their relation to structures of power. It will host contributions which investigate the relation between the politics and cultures of emotions and affectivities in the global South, especially papers which address translocal and transnational positionalities and geographies.

The workshop frames emotions, both as practices and as aspects of individual and collective identity, as operating differentially across a range of racialized and gendered contexts. We are therefore interested in approaches toward global politics and IR which reflect on and problematise universalistic ideas around emotional attachments and contribute to the decolonising of affect studies. We encourage submissions which, for example, examine emotions across the human-non-human boundary and incorporate the human's multi-lateral relationships to the environment, the animal or the speculative. This workshop poses the overarching question: to what extent is the 'turn to affect' in IR predicated upon an orientation towards Western and Eurocentric epistemes? To put it another way, how far have the spatialities and temporalities of the Global South been excluded from affect and emotion studies?

We propose, then, that although the 'affective turn' has been discussed as a phenomenon across the humanities, social sciences and sciences for the past decade or more, more consistently intersectional and postcolonial interventions are needed. We encourage submissions which explore aspects of these and other problematics of affect, through bringing to bear a critical attention to issues of racialized and gendered inequality, and to questions of universality and particularity, as they are articulated at local, national and global levels.
